1. AIB Dissemination

1.1 The AIB may at times contain information that is **critical to flight safety**. Unit PUBSOs are required to disseminate the AIB as widely as possible to relevant staff at their unit particularly aircrew, safety/standards teams, and unit execs.

2. AIS-AF Charting Constraints

- 2.1 Due to exercise support, reduced manning and system updates AIS-AF Charting Section will be unable to fulfil normal AIRAC Cycle Charting support. Users of routine APMs and Auth Maps will experience product delays until after the 2507 cycle.
- 2.2 Users with new requests for charting products are advised to seek already existing products through ASI-AF Operations (ais.af@defence.gov.au).

3. NGA DoD FLIP Planning Books

- 3.1 Users of NGA DoD FLIP Planning Books are to note their gradual transition to softcopy only over the coming years ending Sep 27.
- 3.2 All current NGA DoD FLIP products are available through the NGA's Aeronautical Content Exploitation System (ACES) 1.5. For those unfamiliar with ACES 1.5, contact AIS-AF Operations (ais.af@defence.gov.au) for an ACES 1.5 User Guide.

4. NGA Feedback

- 4.1 IAW with the above transition, users will need to migrate from hardcopy FLIP to electronic FLIP no later than 30 September 2027, CONUS MIM no later than 30 September 2028, and EVCs/all remaining aeronautical, maritime, geographic, topographic, and geomatics products no later than 30 September 2032
- 4.2 AIS-AF is requesting feedback (concerns/comments) to AIS-AF Operations (ais.af@defence.gov.au) by COB 10 Jul.

Civilian IFP

- 5.1 Global Airspace Solutions (GAS) are a civilian Instrument Flight Procedures (IFP) designer that have been contracted to produce IFP at military aerodromes suitable for both military and civilian operators.
- 5.2 These new IFP are to be published initially via AIP SUP for incorporation into DAP E/W. AIS-AF will be liaising with local ATC/Standards to ensure local units are aware of the changes.

6. PCR/ACR Transition

- 6.1 NOTAMs are underway for PCR/ACR transitions into ERSA. Additional ACR/PCR changes to other AIP have been incorporated this cycle.
- 6.2 See Aeronautical Information Circular (AIC) H38/24 at AsA AIP SUP and AIC.

7. ERSA/ERSI Data Changes

- 7.1 In line with Airservices desires for AIP to be in line with ICAO Standards, users of ERSA/ERSI will note the removal of PSI from ERSA/ERSI entries as of the 2512 cycle.
- 7.2 AIS-AF will remove PSI from ADF aerodrome entries when requests for ERSA amendments of ADF aerodromes are actioned. AIS-AF will update ERSI prior to the 2512 cycle.

8. International Products

- 8.1 Butterworth International Terminal Procedures (WMKB ITP)
- 8.2 WMKB ITP dated 17 Apr 25 remains valid WEF 17 Apr 25. The only change has been the addition of Para 4 on Page 2, SI approaches Circling Minima only when a DT promulgated by NOTAM.
- 8.3 The Butterworth IFG (produced by the RMAF) is reviewed each calendar month, with updates to the ITP normally promulgated outside the AIRAC cycle. Due to differences in cyclical production with EFB Data Service Providers and Aircraft Nav databases, AIS-AF strongly recommends all users check the AIS-AF web-portal to determine if there is an updated product and refer to AUS HO NOTAMs for critical amendment advice.
- 8.4 Papua New Guinea MSA/VSA Chart dated WEF 16 Jun 22 remains valid
