#### 1. AIB Dissemination

1.1 The AIB may at times contain information that is **critical to flight safety**. Unit PUBSOs are required to disseminate the AIB as widely as possible to relevant staff at their unit particularly aircrew, safety/standards teams, and unit execs.

### 2. Paper Product Draw Down

- 2.1 AIS-AF have begun advising users of the withdrawal of select publications from routine hard-copy circulation throughout 2023, shifting towards a digital centric distribution model.
- 2.2 Users with an account that routinely receives hardcopy versions of ERSA have been advised of its withdrawal from paper distribution. ERSA will continue to be made available from electronic means.
- 2.3 WEF 07 Sep 23 (2309 Cycle) AIS-AF will also no longer distribute hard copies of FIHA and GPA. These products will be made exclusively available on DPN, the AIS-AF web-portal, and distributed through EFB Data Service Providers.
- 2.4 This decision has been made to assist in redistributing internal resources for other priorities including AusDAFIF expansion. This will also meet CAF's intent to be a climate conscious organisation.
- 2.5 AIS-AF will continue to maintain a print capability for contingency purposes. Users that require access to paper publications will be assisted where possible through looking at alternative solutions.

#### 3. AIS-AF Hazard Log Review

3.1 The AIS-AF Hazard Log has recently been reviewed and a revised document published. Capability Managers, Safety and Standards teams, and users are encouraged to review the Hazard Log in order to understand on going risks associated with AIS-AF products and services

### 4. Temporary Obstacle Notification

- 4.1 AIS-AF have noted a significant increase in temporary obstacle NOTAMs at military bases with the vast majority of these occurring off base.
- 4.2 AIS-AF would like to remind Aerodrome Operators of the requirement to ensure that all temporary obstacles are assessed IAW relevant Aerodrome Manuals and where breaches of the OLS are observed, a PANS-OPS Obstacle Assessment request is sent through to ais.af@defence.gov.au

#### 5. AVDAFIF Note

5.1 After a review of the AIS-AF Hazard Log, a note has been added to the AIS-AF web-portal identifying a potential limitation in AVDAFIF. Users of this database are encouraged to review this limitation prior to using the product. There is nil impact to AusDAFIF or other databases because of this issue.

### 6. Vertical Vector Obstruction Data (VVOD) Extension

6.1 AIS-AF have been notified that the US DoD NGA VVOD database has been extended with support continuing until 31 Dec 24. Users that require continued access to obstacle databases after this time will need to source alternative products. NGA advise that the Table Formatted Aeronautical Data Set - Obstacles (TFADS-O) contains the same essential data as VVOD in a significantly smaller file size with improved processing and download times.

## 7. AI NOTAM Requirements

- 7.1 The ADF EFB team have compiled an easy reference guide on how to source various NOTAM/Alert services for the wide variety of products used by operators (host nation and 3<sup>rd</sup> party).
- 7.2 AIS-AF encourage all operators to read this document to assist in preventing safety incidents using out of date or incorrect data/procedures.

- 8.1 Butterworth International Terminal Procedures (WMKB ITP)
- 8.2 WMKB ITP dated 20 Apr 23 remains valid WEF 10 Aug 23 (2308 cycle).
- 8.3 The Butterworth IFG (produced by the RMAF) is reviewed each calendar month, with updates to the ITP normally promulgated outside the AIRAC cycle. Due to differences in cyclical production with EFB Data Service Providers and Aircraft Nav databases, AIS-AF strongly recommends all users check the AIS-AF web-portal to determine if there is an updated product and refer to AUS HO NOTAMs for critical amendment advice.
